

End-User License Agreement – WINAMP NFT LIBRARY

Effective Date: 20/10/2022

This Agreement is a legally binding contract that includes terms that limit your legal rights and shall govern all access to and use of this Product. You hereby agree, without limitation or alteration, to all the terms and conditions contained herein.

By installing, copying, or otherwise using the Licensed Product, the Licensee agrees to be bound by the terms and conditions outlined in this EULA. However, if the Licensee does not agree to the terms and conditions outlined in this EULA, the said Licensee may not use Product.

If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity and its affiliates to these terms and conditions. If you do not have such authority or if you do not agree with the terms and conditions of this EULA agreement, do not use the Product, and you must not accept this EULA agreement.

Definitions

- "*Licensor or Winamp*" shall refer to the company, Winamp located at is Lennik Road, 451- 1070 Brussels – Belgium.
- "*Product*" shall mean the product available at the following URL: nftlib.winamp.com all associated upgrades, updates, patches, supplemental applications, associated media, documentation and online service provided by Winamp, its affiliates and suppliers, and Extensions distributed by Winamp for use with the Product, whether Licensee installs them at the time of installation.
- "*Extension*" means an extension (a small software program that adds a specific capability to another program) offered by Winamp or other parties as part of the Product for use with the Product.
- "*Update*" means a revision to the Product designated by a change in the version number to the right of the decimal place.
- "*Upgrade*" means a revision to the Product designated by a change in the version number to the left of the decimal place.

Grant of License

- a) Subject to the terms of this EULA, the Licensor hereby grants to the Licensee, a personal, non-transferable, revocable, limited, non-exclusive license during the term of this EULA to possess and to use the Product.
The unhindered usage of the Product is only possible when connecting your digital wallet with the Product. This Product is compatible with a limited range of digital wallets. Please access the Product to get an updated list of compatible digital wallets.
You are permitted to access the Product (for example a PC, laptop, mobile or tablet) under your control. You are responsible for ensuring your device meets the minimum requirements of the Product.
You not allowed to make a charge for distributing this Product, either for profit or merely to recover media and distribution costs.
- b) Winamp is controlled and operated within Europe.
